
One of our lawyers involved in all of our PASS Scheme clinics at client premises is Verity McKay.

She explained: 'I'm part of a team of lawyers which spends a day at the client's site. The first session is on a 'drop in' basis where people can call in and have a chat about any issue and how our services could help.

The second half of the day is divided into half hour appointments which employees have booked in advance to talk through specific issues. There's still no obligation, but if the person then decides to go ahead and engage our services, they will receive the **25% discount on our fees**.

Watch out for cyber fraud Poole Alcock's IT Manager, Partner Chris Joseph answers some of your



Who are the fraudsters targeting?

Everyone and anyone. Hackers are always trying to get into email and shopping site accounts as well as services like games or music providers.

What do they do with the information?

The hackers are probably not directly the fraudsters – but they will sell your details (your email address, passwords etc) to the highest bidder.

How might that affect any dealings I have with Poole Alcock?

Like any law firm, we arrange transactions involving large sums of money such as with conveyancing for the buying and selling of property. Someone who has been monitoring your emails might try and send an email purporting to come from us to introduce fake bank details in an attempt to divert money into their own account.

What are the clues that you have been hacked?

The fraudsters are clever at sending emails that appear to be genuine – copying logos and sign off panels etc. Sometimes a fake email address will have just one letter different from the real thing – john.smiths@company.com instead of john.smith@company.com

How can you counteract that?

We stress to our clients that we will never notify them of a change of bank details by email and ask them to verify sort code and account numbers by phone with a staff member they know before transferring any funds. We have a reminder of this on every email we send.

What is the best way to avoid cyber fraud?

Be aware and be vigilant: new scams and frauds are being devised all the time. It always pays to think twice, and if something doesn't seem quite right – check.

Gazumping: a seller accepts a verbal offer on their property from one buyer, but then accepts a higher offer from another potential buyer. Although inconvenient and frustrating for the first would-be buyer, who thought they had a deal, the seller is within their rights to do this so long as contracts have not been exchanged.

Gazanging: this is where the seller pulls out, deciding not to move, even though they have previously accepted an offer. Again, this is something they are within their rights to do until exchange of contracts.

Gazundering: this is where the Buyer lowers their offer on the property after agreeing a price, threatening to pull out if the lower offer isn't accepted. This can only happen before exchange of contracts.

Ground rent: this is the rent paid to the landlord usually on a leasehold property where there is a long lease and is an additional cost that should be taken into consideration when purchasing a leasehold property. Ground rents are also payable on some freeholds.
