## DEPARTMENT SPOTLIGHT - FAMILY LAW

When parents part, how does the law affect what happens to their children?

Sadly, more people file for divorce at this time of year than any other. It's rarely an easy decision, and members of our highly experienced team of Family Lawyers are here to help at what can be a very difficult and stressful time.



One of the most upsetting issues for couples is how their decision will affect any children they have, and this is a specialist area for Partner Amie Pine. She explains: 'Many people don't realise that the Courts will only get involved with arrangements for children (aged under 18) if parents can't agree things between themselves. There are also a lot of misconceptions about the kinds of rulings the Courts make – here are some of the questions people ask me:

- O Does the Court automatically say that a child should live with its mother?
- A No, the Courts' primary concern is what's best for the welfare of the child and they will look at the individual circumstances.
- **Q** Our daughter lives with me and my ex-husband pays no maintenance, is he still entitled to have regular contact with her?
- (A) Yes. The Courts consider financial arrangements and contact to be completely different matters one is not dependent on the other.

- My children live with my ex-wife during the week, so is it true that I'll only be entitled to have them to stay with me for one week in the summer holidays?
- (A) No, assuming you are both able to offer the children a 'safe environment,' the Courts aim to give parents equal amounts of 'quality time,' i.e. holidays and weekends, wherever possible.
- ① I haven't seen or heard from the father of my eight-year-old son since he was six months old. I want to change his surname to mine, but I've been told that's not allowed is that right?
- (A) Yes and no... if the father's name is on the birth certificate, then he still has 'parental responsibility' despite his absence, and would have to give consent for a change of surname. If he won't consent, or you're not able to get in touch with him, you can go to the Courts and ask them to 'Approve' the name change but that can be a time-consuming and costly process, with no guarantee of success.
- My partner and I are splitting up after eight years and have two children. Will the Courts treat us differently because we're not married?
- A No. In making their decisions about children, the Courts make no distinction between parents who are married, unmarried or in civil partnerships.



**Joint Tenancy:** this is where two or more people have equal ownership of a property, with possession passing automatically to the remaining owner(s) in the event of another's death.

**Leasehold:** This is where you own the property, but the land under which the property is built is owned by the Freeholder. The lease grants you a right to occupy the property for as long as the lease is granted.

**Licensed conveyancer:** a lawyer specialising in property law who has been trained to deal with all aspects of property law and is regulated by the **Council for Licensed Conveyancers.** 

**Local authority searches:** These are searches undertaken prior to exchange of contracts, which look at all the information held by a Local Authority about a property, including any restrictions or charges registered against the land or property and information relating to public highways and planning decisions.
